We are charging \$10 per space per week. If you wish to prepay for the entire 2021 season (20 market days: June 19 -Oct. 13) the cost will be \$125 for each space. ***Prepaying for the season (DUE at Vendor Meeting on June 3rd) gives the advantage of reserving the same space for the season as well as a \$75.00 savings.*** We are a WIC and FMNP approved market and need to send the information to the NYS Agriculture Department in order to get our market approved again this year, please follow the following steps and return to the above address as soon as possible.

Return this paper following these steps:

1. Enclosed please find and read the market rules. Sign at the bottom of this page to signify your agreement.
2. Farmers: Fill out the **CROP PLAN** found with this application (or received from Dept. of Ag and Markets) and return it with the application.
3. Make a copy of your liability insurance certificate and send to us with your application. **Make sure that Lyon Main Street Program is named at the bottom of the certificate.**
4. If you are reserving for the season, enclose a check for \$125.00 (*or bring to the June 3rd Vendor Meeting as stated above*) for each space please make checks out to: **Lyons Main Street Program and designate "Farmers' Market" on the notation line at the bottom.** (If you plan to pay weekly rather than for the season, omit step four.)

*Farmers:

Return signed application, crop plan, copy of insurance certificate, and check (made out as instructed in #4 above if you plan to be a prepaid seasonal vendor).

*Crafters:

On the back, please list the type of homemade items that you plan to sell. Crafters do not need a crop plan, but do need a New York State tax certificate on display at the market. All the above steps are applicable except for the crop plan.

*Prepared food vendors:

On the back, please list the prepared foods that you intend to sell. Fill out the application, and omit Step two. You are responsible for calling the Wayne County Health Dept. and becoming acquainted with and following laws that apply to you. Food vendors are also expected to have and display their New York State tax certificate and either food service or health certificate as well.

*Other vendors:

On the back, please list all products you plan to sell. You **MUST** have a New York State tax certificate on display at the market. All the above steps are applicable except for the crop plan.

Turnover and sign on back.
